**The Road Traffic Act, 2002**

(Act No. 11 of 2002)

**The Road Traffic (Public Service Vehicles Restriction on Night Driving) (Amendment) Regulations, 2021**

IN EXERCISE of the powers contained in section 233 of the road Traffic Act, 2002, and on the recommendation of the Agency, the following Regulations are made:

(1) These Regulations may be cited as the Road Traffic (Public Service Vehicles) (Restriction on Night Driving) (Amendment) Regulations, 2021, and shall be read as one with the Road Traffic (Public Service Vehicles) (Restriction on Night Driving) Regulations, 2016, in these Regulations referred to as the principal Regulations.

(2) Regulation 4 of the principal Regulations is amended by the deletion of sub-regulation (1) and substitution therefor of the following:

Amendment of Regulation 4

(1) A person or an owner of a public service vehicle or a specified vehicle shall not use the public service vehicle or specified vehicle, or cause or permit the public service vehicle or specified vehicle to be used on a public road between 2200 hours and 0400 hours.
